- Levels: Beginner/Entry Level (must have ability to serve, rally & score), Intermediate (match or tournament experience) & Advanced (Championship & Super Championship); Note: levels may be combined
- Date: Saturday, December 14 & Sunday, December 15 (\*will try to complete on Saturday if possible)
- Location: Memorial Park Tennis Center, 1500 Memorial Loop Drive, Houston TX 77007, 832-395-7561
- Format: Six (6) game set with No-Ad Scoring for all levels except Red Ball which plays two out of three games to 7 points; all players guaranteed two rounds in division(s) entered
